The School is required to apply on online for further extension of affiliation alongwith the requisite fee and other documents by 30th June of the preceding year in which the Provisional Allifiation expires. Applications will be accepted after the last date along with the prescribed fee and late fee Rs. 10,000/- per month. (Amended Rule 15.11)

Provisional Affiliation granted to a school will remain valid on re-eight of online application of a school for further extension of provisional affiliation subject to the final decision of the Board (Amended Rule 15.11)
